# **Geothermal Heating Potential**

### **Geothermal Energy – The Heat Beneath Our Feet**

Temperatures fluctuate above ground, but a few feet below the earth's surface the ground remains at a relatively constant temperature. The deeper the depth, the higher the temperature rises. This gives rise to a renewable, low carbon energy source.

### Alternative to Natural Gas

Ireland heavily dependent on gas and oil for heating buildings. Geothermal offers an alternative to heating our buildings, which would bring about reductions in emissions.

### **Carbon Savings**

Geothermal systems operate using electricity and deliver approx. 75% savings on emissions versus gas (more in the most optimum conditions). Ground source heat pumps also require less maintenance than gas boilers.

### Geothermal feasibility study was carried out at Dublin Airport in 2021

Testing completed by geothermal specialist consultants in 2021. Site is an effective geothermal resource suitable for a ground source heat pump (GSHP) system.

#### Government supported technology


Geological Survey Ireland (GSI), a division of the Dept. of Env, Climate & Comm promotes uptake of geothermal, as a renewable heating resource. As the State's proponent of geothermal, they offer supports with regards to resources and best practice.

# Likely the biggest solar array in Dublin

15,000 high-efficiency panels across 11 hectares harnessing

# **Carbon savings**

Reducing carbon emissions by more than 2,500 tonnes annually.**13%** of Dublin Airport's electricity needs will be met with the energy harnessed.

### Phase 2 of Solar Farm

We are currently investigating the most suitable location with plans for 4-8MW of power, and potential incorporating battery energy storage systems (BESS)

## **Glint and Glare**

In 2019 a glint and glare assessment was undertaken in the vicinity of Dublin Airport to identify locations where there was no risk involved with installing panels. The study was very clear; the various assessed sites passed or failed the G&G test.

As solar panel technology has since advanced, in that newer panels have more modern Anti reflective coating (ARC), a new study will be undertaken which may uncover more suitable green field sites.

# daa update

- In October, Dublin Airport welcomed 2.9m passengers.
- daa continues to make every effort to dampen airline demand to comply with the 32 million terminals passenger cap.
- The High Court has granted a stay on the decision by the Irish Aviation Authority (IAA) to cap the number of passenger seats to 25.2 million for summer 2025.
- Judicial Review proceedings will be heard on 3 December regarding the IAA's decision to cap winter 2024/25 passenger seats to 14.4 million.
- Dublin Airport submitted its response on 13 November to Fingal's further Request for Information in relation to the Infrastructure Application.
- Dublin Airport is hiring Airport Search Unit Officers for the Security team with excellent conditions. Full time opportunities are available, and further information can be found on our career's website at <a href="http://www.daa.ie/careers">www.daa.ie/careers</a>
- Development has begun on the new-build Sofitel hotel located at Terminal 2, set to open by late-2026. The airport-linked hotel, comprising 412 guest rooms, will host a suite of features including a restaurant, executive lounge, fitness centre and meeting spaces.
- The Community Fund has closed for this year's second round of applications and the independent Grant Making Panel will meet in December to consider all eligible proposals.
